The sealed tender will be opened in the presence of the bidders or their authorized representatives in the Office of the Registrar at 11.30 A.M. on 02.05.17. The highest bidder shall deposit 50% of the offered amount immediately. After the sale is finalized & confirmed, the balance amount will be deposited within 7 days from the date of acceptance of the tender. The successful bidders shall remove the vehicles from Utkal University campus within 7 days by depositing the full amount of the tendered money or otherwise the bidder shall have to pay the ground rent at the rate of 7% of the bid amount for each day or part thereof till the removal of the vehicle and in such cases the undersigned would not be responsible for any such damage or loss caused to the vehicles. The earnest amount and the 50% of the bid amount are subject to the adjustment at the time of final payment of the tender value.
